| 808 | <p>Parish Highways:</p> <p>The Council observed that despite a request to NCC Highways to cut back the overhanging vegetation along the footpath from Church Lane to the Braybrooke Road, which was causing a hazard to pedestrians, this had not been done. The Council therefore agreed the quote of £250 from local contractor Garry Ritchie to stream the footpath and roadside kerb, cut back footpath and edging to make more presentable, cut back overhanging tree branches and remove waste rubbish from site.
